Streets

Phillip Waller will be meeting with a representative from Tennessee Department of Environment and Conservation tomorrow concerning the water issues at the lower end of town.

He has also been in contact with Virginia Department of Transportation concerning the strip of the road with the potholes on North Cumberland Dr. He was told that VDOT had discontinued maintenance on that part of the road but they would continue to research to find out whose responsibility it is.

Parks and Recreation

The restrooms at Berkau Park will be reopened at the end of March or first of April.

Vehicles are being parked in the dog park lot and left unattended past the closing time. A new sign will be purchased and placed at the entrance of the park listing the hours the park is open.

The County Commission adopted the Claiborne County 10 year Parks and Recreation Master Plan at their last meeting and now each municipality needs to do the same. A resolution will be on the agenda next month.

The town is still awaiting news on the Health Grant. Announcements are expected soon.

Ms. Kotlar was elected to represent the town on the board of the Cumberland Gap Regional Tourism Association. Among the things she plans to do is adding the town events to the Association's website.
