Parks and Recreation – The bathrooms at Berkau Park has been winterized.

Mayor Pucciarelli reported that he met with the new acting superintendent of the National Park. While he is willing to work with the town, he is still not interested in repairing the wooden walkway.

### Tourism/Events

The Victorian Christmas was a success. John Ravnum thanked all those who helped.

Ralph McClanahan explained that he has checked with two different companies and is unable to find insurance to cover the Polar Bear Dip scheduled to take place on January 1, 2019. One of the companies would cover everything but the participants. There was discussion about the possibility of the event becoming an official fire department event therefore be covered under the fire departments insurance. Mayor Pucciarelli will talk to the fire department to make sure they would be willing to take over the event. Since the department is comprised of students he isn't sure how many will be in town for the event.
