<u>Finance-</u> The board reviewed the Profit and Loss vs Actual report for the General Fund. The same report for the Water and Sewer Fund was inadvertently left out. The board agreed to review both reports at the next planning meeting.

Law and Order - There was nothing to report.

Historical – The next meeting will be on Tuesday January 8, 2019 @7:00 p.m.

<u>Streets-</u>The drain on Brooklyn Street (in front of Papa Chum's) has been completed. Ray Paul and Jesse Thompson poured the concrete completing the repair of the drain.

Phillip Waller discussed his concerns regarding the water running down the street at the corner of Colwyn and Ashton Road. Ray Paul reported that he cleaned out and unstopped a drain nearby.

Parks and Recreation – The gates have been installed on the walking trail.

Tourism/Events

The Polar Bear Dip was a success. John Ravnum thanked all those who helped, including the fire department for hosting. Donations for the fire department was not substantial. The board discussed ways to do things differently next year.

Joe Wolfenbarger reported that applications have been sent out to possible vendors for the Antique Festival in April.

<u>Water-</u> The water loss went up from 24% in November to 34% in December. The water used during the flushing of the fire hydrants was not accounted for, so therefore, that could account for a small portion of the water loss.

<u>Sewer-</u> The board discussed the proposed fees from Vaughn and Melton for the generator replacement at the wastewater treatment plant.

Ordinance Number 7-2018- An Ordinance to Amend the Municipal Code to Adopt the Most Recent Edition of the International Building Code This ordinance adopts the 2018 edition, which will replace the 2012 edition.
