Mayor Pucciarelli called for New Business:

<u>Bicycle Grant-</u> Anna Beth Walker, with the Claiborne County Mayor's, office was present at the planning meeting last week to discuss a Bicycle Grant. The county received a twenty thousand (\$20,000) dollar grant (no match) to purchase bicycles and other equipment needed to implement a bicycle rental/loan program. The original recipients, Tazewell/New Tazewell, declined the grant because of liability issues so the county is approaching Cumberland Gap with the opportunity to accept the grant.

Mayor Pucciarelli explained that the bicycles would be checked out as a free service, like a library. Ms. Walker told the board the money has to be spent by November 30, 2020 but the program doesn't have to be up and running until later.

John Douglas made a motion to accept the grant, with a second by Kathy Maxwell. Mayor Pucciarelli called for a roll call vote. Board members voted as follows: Susan Bain- yes; John Douglas- yes; Teresa Fuson- absent; Kathy Maxwell- yes; John Ravnum-yes; Phillip Waller-yes.
