TN Downtown Grant Update- Guardians of the Gap- A representative, from the Guardians, was not present but provided the following update via email prior to the meeting:

- The State of TN has begun issuing contracts to participating communities. Because the Guardians of the Gap is a new recipient of state funds, the process is taking longer than most.
- Once the contract has been issued, the \$15,000 grant project will begin with representatives from Colloredo & Associates (the marketing firm selected to work on the project) paying a visit to the Gap.
- Our TN Downtowns program representatives, Nancy Williams & Bridget Jones, will be checking in with the Mayor and Steering Committee via a Zoom call on Monday, June 12th at 4pm.

Special Event Permit Application- The Mountain Fiesta

Ordinance No. 9-2023- An Ordinance Amending the FY 2022-2023

This ordinance is the final budget amendment for FY 2022-2023, and is based on the estimated amounts for the year ending. It was explained that the amounts are subject to change and if so, will be brought to the attention of the board. This is the first reading of the ordinance. Since the amendment has to be passed before June 30th, the second reading will be held at the special called meeting on June 26, 2023.

John Ravnum made a motion to approve the ordinance, with a second by John Douglas. Mayor Pucciarelli called for a roll call vote. Board members voted as follows: John Douglas- yes; Teresa Fuson- absent; Camille Hall- yes; Bill Linn- yes; John Ravnum-yes; Morgan Wheeler- absent.

Ordinance No. 9-2023- An Ordinance Adopting the Annual Budget and Tax Rate for FY 2023-2024 - This ordinance adopts the annual budget and tax rate for fiscal year beginning July 1, 2023 and ending June 30, 2024. It was explained that the amounts are subject to change and if so, will be brought to the attention of the board. This is the first reading of the ordinance. Since the budget has to be passed before June 30th, the second reading will be held at the special called meeting on June 26, 2023.

The budget includes a fifty cent (.50) raise for three employees (Micheal Ayers, Linda Moyers, and Ray Paul).

Bill Linn voiced his concerns about the process for raises, that they were automatically included in the budget and not based on employee reviews. He stated he has spoken with MTAS and they are sending him more information on the evaluation process. According to Mayor Pucciarelli the codes allow him (the mayor) to give the employees a cost-of-living raise. Since the budget is to be passed by June 30th, there wouldn't be time to put in place an evaluation process, conduct the evaluations, and still make the deadline for the budget. According the attorney the board can pass the budget, as written, then go back and amend the budget once the evaluations are conducted.

John Douglas made a motion to adopt the budget subject to employee valuations to be conducted at a later date, with a second by Bill Linn. Mayor Pucciarelli called for a roll call vote. Board members voted as follows: John Douglas- yes; Teresa Fuson- absent; Camille Hall- yes; Bill Linn- yes; John Ravnum- yes; Morgan Wheeler- absent.

Special Event Permit Application-Car Show Fundraise

The special event application, Car Show Fundraiser, was submitted by Timothy Goins/Crossing the Gap, and is scheduled for September 9, 2023.

The non-profit group, Crossing the Gap, has partnered with Second Harvest Food Bank to feed Claiborne County residents Thanksgiving dinner. All proceeds from the event will go toward that goal. At this time the proposed area for the event includes only Colwyn Street, in front of Festival Park, down to Merlyn Street.

John Ravnum made a motion approving the application, but also giving the approval for Merlyn Street to be closed and used for the event if needed, with a second by John Douglas. Mayor Pucciarelli called for a roll call vote. Board members voted as follows: John Douglas- yes; Teresa Fuson- absent; Camille Hall- yes; Bill Linn- yes; John Ravnum- yes; Morgan Wheeler- absent.
