The Board of Mayor and Alderman met in regular session on March 6, 2017 with Mayor Pucciarelli calling the meeting to order at 7:00 pm at the Town Hall building, 330 Colwyn, Cumberland Gap, TN.

Mayor Pucciarelli called for approval of the minutes. Chuck Coffey made a motion to the approve minutes, with a second by Susan Bain. Mayor Pucciarelli called for a roll call vote. Mayor Pucciarelli next called for the Financial Report. Town Recorder, Linda Moyers, reported the balances of all the accounts. Mayor Pucciarelli called for a motion to approve the Financial Report. Chuck Coffey made a motion to approve the financial report, with a second by Jerry Hopson. Mayor Pucciarelli called for a roll call vote. Mayor Pucciarelli directed the meeting to approval of the bills. Town Recorder, Linda Moyers, reported the total bills due for all the accounts. The mayor skipped to Item 1 under New Business:

#### Audit Report

Richard Hill presented the audit report for fiscal year ending June 30, 2016. In compliance with the new state law, the water/sewer activities was in a separate fund. The general fund had \$13, 794 more revenue than expenditures, while the Drug Fund had \$160.00 more expenditures than revenue. The water/sewer fund had \$47,691 more expenditures than revenue. According to the new state law the water/sewer fund cannot lose money two consecutive years. If the fund shows a loss two consecutive years the utility will be referred to the Water and Wastewater Finance board and they will review expenditures and rates. The utility must include depreciation as an expense. The money is budgeted but it is not something that you write a check for. You must have the revenue to cover that expense and that is where raising rates come in. Expenditures vary from year to year so therefore rates do not have to be raised based on this audit. City Recorder, Linda Moyers, reported that so far this fiscal year the fund is not showing a loss.

There was only one audit finding (the same as previous years): segregation of duties.

## **Streets**

Dennis Earls submitted a quote, totaling \$3,650, for the following repairs: sidewalkramp in front of Angelo's; grate at Angelo's; grate on Pinnacle Alley; grate on Lynn Ave.; grates at Cumberland Hotel. He will furnish the materials, with the exception of the grates, and the town will furnish the backhoe and gravel.

The quote did not include repairing the drain at John Douglas's driveway. That repair will be done by Ray Paul and Jesse Thompson.

The goal is to include all merchants in town instead of bringing in outside vendors/exhibitors. There will be an admission charge for the wine tasting, but that will be up to the wineries to set the admission fee.

A new emergency water plan was drafted per state regulations. The plan includes chain of command in case of emergency. At least three of those people are required to keep a copy at home.

#### **Sewer**

The wastewater facility was inspected by the state last month and scored 100%.

#### Fire Department

The department is participating in several training activities in conjunction with the county. The dedication for the renaming of the dog park was held on February 15, 2017. The park is now the Kaitlyn DeVries Memorial Off- Leash Dog Park.

Steve Clouse spoke up concerning his building at 601 Pennlyn Street. He explained that he was issued a building permit then a stop work order. There have been multiple Historical Zoning Commission meetings, discussions, and controversy concerning the building for about 4 months. Mr. Clouse asked if there was anything the Board of Mayor and Alderman could do to help resolve the issue and lift the stop work order. Mayor Pucciarelli told Mr. Clouse that the Historic Zoning Commission is the only one who can make the decision. Several options will be discussed at the HZC meeting tomorrow night, such as issuing an order for demolition or taking legal action.

The new owners of the Olde Mill Bed and Breakfast introduced themselves. The board welcomed them to Cumberland Gap.

Kathy Maxwell spoke up concerning the complaint that was made against her dogs. She explained on the day in question she inadvertently left the door open to her sun deck while she left to run errands. When she came back she realized that two of the dogs had went out on the deck and the door closed them out. Someone spoke up on her behalf and told the board he walked his dogs passed the house on the day in question causing Ms. Maxwell's dogs to bark louder. He also stated he was asked to pause while someone videoed the exchange and stopped once he walked past the house.

## <u>Memorandum of Understanding (MOU) Between the Town of Cumberland</u> <u>Gap/CGVFD and LMU-CVM Student Government Association</u>

This agreement establishes requirements, operating standards and expectations for LMU-CVA SCA at the Cumberland Gap Off-Leash Dog Park.

There was some concerns regarding the below statement: "One event to raise money for Cumberland Gap Off-Leash Dog Park may be held each quarter in the dog park without going through city planning or other procedures". Mayor Pucciarelli stated that the board should be notified in order to inform the residents on that street. Chief Wilkinson stated that not all fundraisers would be held in the park. The wording will be changed to say the board will be notified of fundraisers.
